Solicitation No. 196 – Request for Proposal for Audit Services which is scheduled to open at 11:00 A.M. CT, December 9, 2019 BREC – Recreation and Park Commission for the Parish of East Baton Rouge

The following are questions, answers as well as clarification to the inquiries received during the inquiry period for Solicitation No. 196 – Request for Proposal for Audit Services are as follows:

- Question 1: Clarification Section 2.6.2(d) Technical Cost of Services incudes references to IRS Form 990 tax return review and preparation. The RFP does not include any information or guidance related o the scope of services requested by BNREC related to IRS Form 990. Please provide information you feel is relevant to the preparation and review of IRS Form 990. At minimum:
 - 1. Please provide the organization's name under which the form 990 is filed.
 - 2. Is the form 990 filed for BREC or a related organization
 - 3. If the scope of service includes review of a previously prepared form 990, who is responsible for the preparation of the form.
- Answer 1: BREC does not file form 990.
- Question 2: Clarification Section 1.30 Insurance Requirements includes a provision that requires proof of general liability, business auto, and workers compensation insurance, and that BREC be listed as additional insured and/or certificate holder for these policies. I would like verification that this information is in fact a required part of the RFP or assurance that it was inadvertently included in the RFP and may be omitted form the proposal. If it is required, please provide your purpose for requiring these policies from a Public Accounting Firm providing services related to a financial statement audit and how these policies would provide additional benefit to BREC during the performance of a financial statement audit.
- Answer 2: The Insurance Requirement is a general statement and cannot be omitted. If a responding Proposer desires an exclusion to any of the required provisions under this requirement they may elect to provide details of the reason(s) for the coverage exclusion; including the type coverage(s) and/or insurance amounts. BREC will make every effort to consider the request for exclusion and provide a response of acceptance or denial, including the basis for the resulting decision.
