- 1. Budget Information
 - a. The Superintendent, upon recommendation of the Chief Financial Officer, may at any time authorize the transfer of any unencumbered balance of an appropriation, or portion thereof, to supplement another appropriation made in the same budget to the same functional program, or unit thereof including but not limited to the division, park location, park revenue division or department to meet total appropriations and/or forestall a deficit. This authority is granted to allow such action along with the establishment of a balanced budget and maintenance thereof after its adoption and up until the next adoption. Such an act will be viewed as an amendment to the budget for the aforementioned purposes.
